## **SECTION A INTRODUCTION**

The following Disciplinary Procedures shall apply to all football which is played under the jurisdiction of the Cayman Islands Football Association ("CIFA" or "Association") involving a full or associate member club, or such clubs that play in competitions which involve a full or associate member club and which are included in the Association's Competitions. These disciplinary procedures will apply not just to reports by match officials relating to incidents and/or acts of misconduct occurring at a match, but also to investigations of such incidents and acts by the Disciplinary Committee.

These disciplinary procedures shall apply specifically and separately to each of the following competition groups, subject to the transfer of suspensions to higher age groups under certain circumstances, as noted in these procedures:

- (i) Men's senior league and cup competitions
- (ii) Women's senior league and cup competitions
- (iii) U23 men's league and cup competitions**
- (iv) U17 (boys) youth league and cup competitions
- (v) U14 (boys) youth league and cup competitions
- (vi) U15 (girls) youth league and cup competitions
- (vii) CIFA – sanctioned friendly matches.

Any competitions or matches organised by CIFA in addition to those noted above shall be officially included within the scope of these disciplinary procedures at the commencement of those competitions.

In these procedures, references to incidents and/or acts of misconduct occurring "at a match" shall be deemed to include any such incidents and/or acts, which occur prior to, during or after the match in question.

In these procedures, words referring to the male gender are merely for the convenience of this document, and apply equally to male and female persons.

## **SECTION B DISCIPLINARY PROCEDURES**

**OBJECTIVE:** To ensure that reportable incidents are recorded by appointed officials; that those reports are properly submitted to the Association for action; and that punishments, where necessary, are timely and reasonable, and the process is transparent.

### **1. Offences: Reporting by Match Officials**

- 1.1. Referees will administer cautions and sendings-off in accordance with the Laws of the Game.
- 1.2. Referees (and where applicable, assistant referees, fourth officials and match commissioners) shall submit standard report forms to the Association, stating the details of the offence. The standard report forms are shown in Appendices 1 to 4.
- 1.3. These standard report forms are to be received by the CIFA Office no later than the second (2<sup>nd</sup>) day following the match, in accordance with CIFA's Competition Rules, sections H 4.1 and H 4.2.
- 1.4. In the case of a player who is sent off for receiving a second caution, the referee must report the two offences which resulted in the player's dismissal.
- 1.5. If a referee considers that a player's sending off is of such a serious nature that it may warrant consideration by the Disciplinary Committee as an exceptional case of misconduct, he shall submit, in addition to the report form, a letter fully detailing the incident. A referee may also act in this regard upon the advice of an assistant referee (and fourth official when applicable) and in such cases the assistant referee (or fourth official) shall also submit, in addition to the report form, a letter fully detailing the incident.
- 1.6. **Other Incidents Occurring Before, During or After a Match.** Referees and where applicable, assistant referees, fourth officials and match commissioners, must submit to the Association, a detailed report on any other incident which occurs before, during or after a match, such reports to be received at the CIFA Office no later than the second (2<sup>nd</sup>) day following the match.
- 1.7. Where other incidents occur, and such offence is committed by a player, the referee shall inform an appropriate club official (e.g. Secretary, Director, Manager or Coach), as soon as possible after the match, that a

report will be made to the appropriate authorities detailing the nature of the offence.

- 1.8. All such incidents must be reported to the Association by the referee and, where necessary, the assistant referee(s) (and fourth official when applicable), by means of a letter.
- 1.9. **Misconduct in Non-CIFA League Football.** In cases where misconduct involving a player of a CIFA-registered club requires to be reported from a match or a competition not referred to within this section of these Procedures, the referee and, where necessary, assistant referees (and fourth officials when applicable), will do so in the manner described in the foregoing sections.

## **2. Offences: Notification to clubs by CIFA**

### **2.1. Cautionable Offences.**

- 2.1.1. Where a player has been cautioned in any match (abandoned or not), his club will be notified by the Association of the offence which has been reported by the referee.
- 2.1.2. Notification as in 2.1.1 above will occur by transmission of the relevant information to the Team Representative's registered e-mail address, at least on a weekly basis, and more often where a timely suspension is warranted.
- 2.1.3. The notification will include the number of cautions recorded against the player in the last five matches played by his team, and any automatic suspension that arises therefrom.
- 2.1.4. An administration fee (see Appendix 1) will be charged to the club for the processing of each referee report.
- 2.1.5. Clubs may at any time request details of the current season's record of cautions that applies to their teams.

### **2.2. Sending-off Offences.**

- 2.2.1. Where a player has been sent off in any match (abandoned or not), his club will be notified by the Association of the offence which has been reported by the referee.
- 2.2.2. Notification as in 2.2.1 above will occur by transmission of the relevant information to the Team Representative's registered e-mail address, on a weekly basis.
- 2.2.3. The club will also be advised of the number of red cards the player has received in the current season of that competition, and will advise that he is subject to the punishment as detailed in Section 4 of these Disciplinary Procedures. The automatic 1-match suspension stipulated in Section 4 applies immediately and is not dependent upon receipt of the confirmation referred to in 2.2.2 above.
- 2.2.4. An administration fee (see Appendix 3) will be charged to the club for the processing of each referee report.
- 2.2.5. Clubs may at any time request details of the current season's record of sendings-off that applies to their team/s.

- 2.3. If a referee has reported that a player's sending-off is of such a serious nature that it may warrant consideration by the Disciplinary Committee as an exceptional case of misconduct in accordance with Section 4, the Association will advise his club that the incident is being referred to the committee.
- 2.4. **Other Incidents Occurring Before, During or After a Match.** Where the incident involves a player and an offence is committed by the player, the Association will inform the player's team that a report has been submitted to the Association. Incidents involving offences committed by players which are reported by referees will be dealt with by the Disciplinary Committee. All other incidents reported will be dealt with by the Disciplinary Committee or other Standing Committee of the Association as appropriate in the circumstances.

### 3. Punishment for offences

- 3.1. **Yellow cards.** A yellow card is customarily issued for cautionable offences. Accumulation of yellow cards by any player over the course of a specified number of consecutive matches played by his team may result in the player being given a suspension, in accordance with Section 4: Schedule of Penalties.
- 3.2. **Red cards.** A red card is customarily issued for sending off offences, including the issue of a second yellow card. Players receiving red cards will face a 1-match automatic suspension in that competition, irrespective of the sending off offence. Players may receive an additional suspension under certain circumstances, with the total suspension to run until such time as his club has completed the requisite match or matches in accordance with Section 4: Schedule of Penalties.
- 3.3. **Other Incidents Occurring Before, During or After a Match.** Where an incident involves a player and an offence is committed by the player, the player may be suspended for a specified match or matches, as determined by the Disciplinary Committee, or other standing committee as has jurisdiction over the incident in question, per 2.4 above.
- 3.4. **Serving of Suspensions.** Suspensions incurred by players shall be served in the competition in which they are incurred, subject to exceptions 3.6.2 and 3.6.3 below.
- 3.5. **International eligibility.** During any period of suspension resulting from an offence or offences committed in club competition, a player shall be eligible for selection to International Matches.
- 3.6. **Outstanding Suspensions.**
  - 3.6.1. Any suspension, or part thereof, which remains outstanding at the end of a season, or any extension thereof, must be served from the commencement of the following season in the competition in which it is incurred except when the following section applies.
  - 3.6.2. In the case of a player who becomes ineligible because of age conditions to play in the same youth competition for the following season, any outstanding suspension will be applied to his new age group competition for that season.
  - 3.6.3. If a youth player has not completed his suspension in his youth league, whether this is at the end of a season or during a season, and transfers or otherwise becomes registered for another club which does not field a youth team in the same league, then the

outstanding portion of his suspension shall apply to his new team and new age group competition. However, if such player does not take the field for his new club for 12 months from the date of the previous match missed by him, then any un-served portion of his suspension shall be deemed completed.

3.7. A confirmation notice of outstanding suspensions, and yellow cards carried forward, will be issued to clubs prior to the commencement of each season.

3.8. **Abandoned Matches - Misconduct and Suspensions.**

3.8.1. If a match is abandoned, any yellow or red cards issued during that match will be recorded on the player/s applicable disciplinary record/s. The player/s will be subject to any standard punishment for the offence.

3.8.2. Where a player is serving a suspension, an abandoned match shall not count as a completed match unless the result stands.

## 4. SCHEDULE OF PENALTIES

### 4.1. Yellow card accumulations

- 4.1.1. If a player accumulates 3 yellow cards before his team has completed 5 matches in the Season, he will be suspended automatically for a period covering 1 match.
- 4.1.2. If a player accumulates 4 yellow cards before his team has completed 5 matches in the Season, he will be suspended automatically for a period covering 2 matches.
- 4.1.3. If a player accumulates 5 yellow cards before his team has completed 5 matches in the Season, he will be suspended automatically for a period covering 3 matches.
- 4.1.4. If, after 5 matches have been played by a team, a player accumulates 3 yellow cards over a period covering the last 5 matches played by the team, he will be suspended automatically for a period covering 1 match.
- 4.1.5. If, after 5 matches have been played by a team, a player accumulates 4 yellow cards over a period covering the last 5 matches played by the team, he will be suspended automatically for a period covering 2 matches.
- 4.1.6. If, after 5 matches have been played by a team, a player accumulates 5 yellow cards over a period covering the last 5 matches played by the team, he will be suspended automatically for a period covering 3 matches.
- 4.1.7. Yellow cards accumulated over the last five matches played by a team remain in effect despite any suspensions served.
- 4.1.8. A player who is dismissed from the field of play for a second yellow card will be suspended automatically for one match. The first caution offence will be accumulated to the player's total, which may also require a further suspension under the above paragraphs.
- 4.1.9. Any suspension arising from the accumulation of caution offences shall commence for the match following that of the player's last offence. The suspension shall cover all domestic League and Cup matches until such time as the player's team has completed the number of matches appropriate to the player's punishment in approved Competitions.

- 4.2. If the reporting of offences by referees is carried out on a timely basis, and the communication of the offences by CIFA is also timely, then players and clubs should be advised of the minimal suspensions (due to three yellow cards in five matches) prior to the offending player playing another match, and possibly receiving another yellow card and activating a greater suspension. However, occasionally, the timeliness is not as expected, and clubs may find players are required to be suspended later than would otherwise be the case. Most clubs may not have the record-keeping in place to track yellow card offences themselves, and will be relying on CIFA to provide that information. However, if a club is maintaining yellow card information, and voluntarily suspends a player in accordance with the above yellow card suspension procedures, then the club may use that information to apply to cancel a suspension for the same offence or yellow card which is reported later by the Association. This may only occur with the approval of the Competitions Committee, and then only on the basis of records received, confirming the voluntary suspension.
- 4.3. **Red cards: Automatic suspensions.** Players receiving a red card, whether for a second yellow card or otherwise, shall be automatically suspended for one match, that match being the next match that the team plays.
- 4.4. **Red cards: Additional suspensions.** The additional suspension refers to the number of matches that a player is suspended, in addition to the automatic suspension. Standard suspensions are the combination of automatic and additional suspensions, and are as follows:

- 4.5. Players receiving red cards for Violent Conduct, Serious Foul Play or spitting will also be required to appear before the disciplinary committee at its next meeting.
- 4.6. Players receiving a 3<sup>rd</sup> red card for the season, irrespective of the offence, shall be required to appear before the Disciplinary Committee at its next meeting.

4.7 **Multiple red cards in a season.** The Association regards the accumulation of multiple red cards by the same player during a single season to be a situation requiring a greater punishment. That greater punishment is an attempt by the Association to discourage persistent and serious misconduct.

Offences for which red cards can be given are included in FIFA’s “Laws of the Game” under section 12 entitled Fouls and Misconduct. For the purpose of dealing with CIFA players who receive more than one red card in a single season, those sending off offences are grouped into CAPITAL offences (comprising serious foul play, violent conduct and spitting) and NON-CAPITAL offences (the remainder). In the table below, CAPITAL offences are denoted by a “C” and NON-CAPITAL offences by an “N”.

The following table explains the extent of any punishment where 1 or more red cards are received by the same player during a single season. The type of red card received by a player (C or N) plus the sequence in which those cards are received will determine that punishment. The term “SCALE” refers to the standard suspension normally awarded for a single red card for the latest offence.

The disciplinary committee will have scope (within previously agreed boundaries, if any) to amend the suspension further, based on special circumstances.

For example, if a player receives a 2<sup>nd</sup> red card for violent conduct, and it is the player’s 2<sup>nd</sup> CAPITAL offence this season, his suspension will be

SCALE x 2, which is 3 matches x 2, = 6 matches. The disciplinary committee's adjustment for special circumstances, if any, will apply to this 6 match figure. So if in their opinion, the circumstances of the 2<sup>nd</sup> offence warrant an extra match ban, then that would be 7 matches.

Players brought before the Disciplinary Committee where their 2<sup>nd</sup> red card is for a "C" offence, or where they have received a 3<sup>rd</sup> red card for any offence, shall cause their club to be fined a minimum of \$100 for each appearance.

## **SECTION C**

### **THE DISCIPLINARY COMMITTEE**

1. The disciplinary committee shall be formed in accordance with the Constitution of the Cayman Islands Football Association.
2. The disciplinary committee shall be obliged to meet on the following occasions
  - 2.1. When a player has been sent off for violent conduct, serious foul play or spitting;
  - 2.2. When a player has received a 3<sup>rd</sup> red card for the season, irrespective of the offence;
  - 2.3. Where a charge of other misconduct has been noted by the match officials or match commissioner (and has been referred to the disciplinary committee by the CIFA Executive);
  - 2.4. Where a charge of other misconduct has been initiated by, or otherwise reported to the CIFA Executive and referred to the disciplinary committee.
  - 2.5. For purpose of clarity, players receiving red cards for offences which normally attract only a 1-match suspension, and who are not subject to other charges of misconduct as in 2.3 and 2.4 above, shall not be required to attend a meeting of the disciplinary committee, unless the red card in question represents the player's third red card of the season.
3. Disciplinary measures shall be taken by the disciplinary committee in accordance with the Constitution of the Cayman Islands Football Association, which are:
  - 3.1. To caution
  - 3.2. To censure
  - 3.3. To fine, subject to a maximum of \$500 per incident
  - 3.4. To suspend from all or any specific football activity, either permanently or for a stated period
  - 3.5. To suspend, or expel from membership of the Association
  - 3.6. To deduct points for teams misconduct

#### 4. Powers of the disciplinary committee.

- 4.1. The disciplinary committee shall take disciplinary measures in accordance with Section 3: Schedule of Penalties in Section 3, above, which shall be MINIMUM sanctions against players.
- 4.2. The disciplinary committee shall endeavour to meet within 1 week of the offence.
- 4.3. The disciplinary committee has the authority to increase the sanctions against players, as it sees fit, based on the circumstances of the incident/s under review.
- 4.4. The disciplinary committee has the power to levy fines for misconduct. However, the committee shall not levy a fine merely in respect of a player having to attend a disciplinary committee meeting, unless it is in respect of a player's 2<sup>nd</sup> or 3<sup>rd</sup> appearance before the committee, in which case a minimum fine of ONE HUNDRED DOLLARS shall be applied.
- 4.5. The secretary for the disciplinary committee shall maintain records of decisions taken where the sanctions are in excess of the minimums noted in Section 3: Schedule of Penalties, in order for the committee to be consistent in its decisions. These records shall be readily available for the committee for its deliberations.
- 4.6. The records of decisions taken noted in the previous paragraph shall be available for presentation at the periodic meetings of the CIFA Executive.
- 4.7. The records of decisions taken as noted above shall be made available on request by any member of the Association.
- 4.8. The disciplinary committee, under especially mitigating circumstances, may recommend that sanctions against any player be **less than** the stated minimums. The disciplinary committee's recommendations shall be presented to the CIFA Executive, either at a periodic meeting, or by other means (particularly if a quick decision is important). The CIFA Executive shall then rule on the recommendation. The General Secretary shall maintain records of all such recommendations that are confirmed by the CIFA Executive, so that decisions taken may be consistent.
- 4.9. The disciplinary committee may consider disciplinary measures against a team or against any other person or body associated with

members or officials of the Association. Any such disciplinary measures shall comprise recommendations to the CIFA Executive, who will, in turn, rule upon the recommendations.

- 4.10. For each incident considered by the disciplinary committee, it shall cause the issue of a report, which shall clearly state the following:
  - 4.10.1. The date of the meeting, and the committee members present
  - 4.10.2. The name of the player and team he represents, plus the name/s of any other team officials accompanying the player at the meeting
  - 4.10.3. The name/s of all other attendees at the meeting, and their reason for attending the meeting
  - 4.10.4. Date of offence and team's opponents, and the nature of the offence under consideration
  - 4.10.5. The decision or recommendation of the committee
  - 4.10.6. The applicable section of the Schedule of Penalties covering the decision of the committee
  - 4.10.7. An explanation of any sanction which is imposed in addition to the stated minimums
  - 4.10.8. Any other pertinent information
  - 4.10.9. The report shall be dated, and signed by the meeting chairman or secretary (electronically if necessary).
- 4.11. The disciplinary report referred to in the previous section shall be issued to the player's team on the first business day following the disciplinary meeting.

## **SECTION D MISCELLANEOUS**

### **1. Claims of Mistaken Identity**

- 1.1 Claims of mistaken identity, concerning a player cautioned or sent off in a match, will be initially considered by the Competitions & Tournaments Committee, provided that the player's club submits to the Association the particulars upon which the claim is founded within two (2) days of the match. The matter may then be forwarded to the Disciplinary Committee if the Tournaments & Competitions Committee is unable to resolve the issue.
- 1.2 Any sanction(s) which arise from a claim of mistaken identity will be held pending until the consideration/investigation is completed.
- 1.3 If necessary, the Disciplinary Committee shall convene and will meet no later than two (2) days before any automatic penalty is due to take effect.
- 1.4 For the purposes of the consideration of such claims, a minimum of two members of the Disciplinary Committee will form a quorum.
- 1.5 If the members of the Disciplinary Committee involved in considering the claims are not satisfied that mistaken identity has been proved, the claim will be dismissed and the referee's decision and the sanction(s) will remain. Such a decision in this regard is final and binding and shall not be the subject of appeal.
- 1.6 If the members of the committee are satisfied that the claim warrants further investigation, it shall be referred to the next full meeting of the Disciplinary Committee.
- 1.7 If it is determined that mistaken identity is proved, the caution or sending off, where relevant, will be rescinded. The Disciplinary Committee will retain discretion to take action, as it deems appropriate, against the correct offender.
- 1.8 Accredited televised match recordings may be used to assist in determining claims of mistaken identity.

## 2. Claims of Wrongful Dismissal

2.1 In the case of a claim for wrongful dismissal for serious foul play, violent conduct or spitting at an opponent, the particulars upon which a claim is founded must be submitted by the player's club to the Association within two (2) days of the match. An appeal fee must be submitted with the claim for wrongful dismissal.

The sanction(s) arising from any sending off which is subject to a claim, will be held pending, until the consideration or investigation is completed.

**SECTION E  
DISCIPLINARY APPEALS**

1. **Right of Appeal.** A player who is disciplined by the Disciplinary Committee under these Disciplinary Procedures has the right of appeal against the decision of the committee to the Appeals Committee of the Association. He will be advised of this right at the meeting or, if the decision was, for any reason, not made known to him at such meeting, by the letter intimating or confirming the decision. An appeal hearing shall neither be conducted as a re-hearing of the case nor shall fresh evidence be permitted except with the permission of the Appeals Committee.
2. **Procedures for Lodging an Appeal.** An appeal from a player must be dispatched by letter to the Secretary within seven days after the date of the meeting at which the decision appealed against was taken unless for any reason the decision was not made known to the player at such meeting, in which case it must be dispatched by letter to the Secretary within seven days after the date on which the decision was intimated by letter to the player.
3. A deposit shall be lodged with an appeal as follows:

For players of clubs in Senior Men's competitions	CI \$100
For players of clubs in Senior Women's competitions	CI \$ 50
For players of all other clubs and leagues	CI \$ 25

At the Appeals Committee's discretion, the deposit will be forfeited if the Appeal is dismissed.
4. **Statement of Grounds for Appeal.** In lodging an appeal the player (or a Club official, on behalf of the player) shall state fully in writing the grounds for the appeal.
5. **Representation of Appellant.** One accredited official of his club may accompany the player at the appeal hearing.
6. **Composition of the Appeals Committee.** The Appeals Committee shall be formed in accordance with Article 20.1 of the CIFA Articles and Memorandum of Association.

7. **Powers of the Appeals Committee.** The Appeals Committee shall have the power to:
- 7.1. Affirm the decision of the Disciplinary Committee;
  - 7.2. Uphold the appeal by setting aside the decision appealed against and quashing any penalty imposed;
  - 7.3. Uphold the appeal in part by setting aside part only of the decision appealed against;
  - 7.4. Substitute for the decision appealed against a decision to find the appellant guilty of a lesser offence and/or to impose a lesser penalty or penalties in respect thereof;
  - 7.5. Refer the case, or any part of it, back to the Disciplinary Committee;
  - 7.6. Take any step, which, in the exercise of its discretion, the Appeals Committee considers it would be appropriate to take in order to deal justly with the case in question.
8. If the appeal is unsuccessful, the player may be held liable in all or part of the expenses of the meeting, subject to the discretion of the Appeals Committee.
9. An appellant, prior to the hearing of the case, may withdraw an appeal, by notifying the Association of such in writing. The appeal will, upon the Association's receipt of such notification, be deemed to be abandoned and the original decision, against which the appellant initially took exception, will be regarded as final and binding. Upon the withdrawal of an appeal, the appeal deposit will be automatically forfeited. The appellant may be held liable in all or part for the expenses of the appeal procedure subject to the discretion of the Appeals Committee.
10. Decisions of the Appeals Committee. The decision of the Appeals Committee shall be final and binding on all parties concerned.

## **11. Miscellaneous Provisions**

- 11.1. Notwithstanding the exceptions allowed for by Section D, appeals against cautions or sendings off will not be considered.
- 11.2. A player (or a player/manager or player/coach, etc., when suspended as a player) may not occupy a position, in any capacity, in or in the vicinity of the players' tunnel, technical area or substitutes' bench or on the track or playing surface at any match during the period of a suspension.

- 11.3. Where a registration of a player is transferred to another club or where a player becomes registered for another club, and where in each case his new club is governed by a different section of the Disciplinary Procedures in comparison to the club he had previously been registered for, the player's applicable League disciplinary record, or general disciplinary record, will be utilised to determine any suspension which may be incurred by him in accordance with a Fixed Scale of Suspensions.
- 11.4. The Disciplinary Committee will deal with all breaches of the Disciplinary Procedures, including players who have been fielded in a match or matches whilst under suspension, and will take such action against the player and/or his club and/or any official condoning or encouraging such a breach, as it deems appropriate.
- 11.5. A player who is sent off whilst playing in a match as a trialist for a club, which falls under the jurisdiction of the Disciplinary Procedures and who is registered for a club in membership of an Affiliated National Association, will be required to serve the suspension he incurs in the grade of football in which he normally plays. The relevant Affiliated National Association will be requested to apply the suspension within the football played under its own jurisdiction.
- 11.6. A player who is temporarily registered by the Association pending receipt of a delayed International Transfer Clearance letter and who is sent off whilst playing in a match for his senior club will be required to serve the suspension he incurs in the grade of football in which he normally plays. The relevant Affiliated National Association will be requested to apply the suspension within the football played under its own jurisdiction.
- 11.7. The Disciplinary Committee will deal with all reports received from other National Associations, the Confederations or FIFA, concerning the misconduct of players of clubs, which fall under the jurisdiction of the Disciplinary Procedures.

**SECTION F**  
**APPENDIX 1**  
**SCHEDULE OF FINES**

- (a) The responsibility for fining players for field offences is left with the club.
- (b) Fines levied by the Association in respect of player misconduct are payable by the player's club.
- (c) The Association will advise clubs of the accumulated totals of fines, on a periodic basis, and clubs shall pay those amounts to the Association as and when requested to do so.
- (d) The Association reserves the right to deduct any accumulated fines from any prize money due to the club at the end of the season.
- (e) Clubs may request an updated position on outstanding fines at any time, and may pay those fines in advance of being requested to do so.
- (f) **FINES.**
  - i. For a first yellow card in any match
    - TEN DOLLARS
  - ii. For a second yellow card in any match
    - FIFTEEN DOLLARS
  - iii. For each red card, except when it is for a second yellow card
    - TWENTY-FIVE DOLLARS
